# **AIRPORTS**

Hutchinson has a small airport but does not handle large aircraft. Kansas City and Oklahoma City are within driving distance.

# **ON SITE CAMPING**

The Kansas State Fairgrounds RV Park contains 211 full service 50-amp hook-ups.

# **SHOW RULES**

This is an ARBA, KSRBA and ASRBA sanctioned show and will be governed by the latest ARBA show rules. Filing of an entry indicates acceptance of these rules. The judging order will be set by the superintendent. SCSC reserves the right to add or change judges as they see fit.

Entries accepted online only at <a href="www.easy2show.com">www.easy2show.com</a> A \$30.00 surcharge will be assessed for a check returned unpaid. Until the check is paid, exhibitors will not be allowed to enter any further KSRBA shows. PayPal and Cash app will also be used. Animals may enter the barn between 10 AM and 10 PM on Friday April 19th CST. All exhibitors (open and youth) must check in with the show secretary by 9 pm April 19, 2024. Otherwise, the entry will be pulled in belief exhibitor is not present. On Saturday all feeding should be completed by 4:30 pm. The barn will close at 5 PM and <a href="will-not-be-reopened Saturday">will not-be-reopened Saturday</a> evening.

Owners are responsible for getting their own rabbits to the show table. Carriers are not provided.

Neither KSRBA, SCSC nor the Kansas State Fair Grounds will be responsible for any injury or accident occurring during the show. Please understand the below Kansas law before entering, it is also posted in the show room.

### KS LAW K.S.A. 60-4001 THROUGH 60-4004

UNDER KANSAS LAW, THERE IS NO LIABILITY FOR AN INJURY TO OR DEATH OF A PARTICIPANT IN DOMESTIC ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF DOMESTIC ANIMAL ACTIVITIES, PURSUANT TO SECTIONS 1 THROUGH 4, YOU ARE ASSUMING THE RISK OF PARTICIPATING IN THIS DOMESTIC ANIMAL ACTIVITY.

Parents are responsible for damage done by their children, please keep track of them. All activities will be held in the rabbit and poultry building. Convention attendants should not enter any other building on the grounds. We will do all within our power to have a safe show, please do the same.

Equipment and Sales Displays must have permission from the show superintendent to set up. There will be a charge of \$75.00, plus \$10.00 per table rented. Please contact the show committee. Deadline is April 1st, 2024.

Any animal showing signs of illness or disease will be removed from the showroom. "Show superintendent reserves the right to refuse entries from exhibitors placing an entry from all locations within 50 miles which has had a confirmed outbreak of RCV/RHD/VHD within the past 60 days of the entry deadline.

Due to limited space all rabbits in the show room must be entered. No animals will be allowed on the fairgrounds not entered in show or in a purchased sale coop. Sale Coops are available for \$5.00 each-only one rabbit per cage and must meet ARBA minimum weight. Sale coops available first come basis deadline for reserving sale coops is April 17th. 2024 Grooming tables and chairs should not block isles.

This show does not allow animals under ARBA minimum breed weight in the show barn.

Interpretation of the show rules will be by the show officials.
